# INTRODUCTION

During September 21 - October 5, 1973, James S. Dodge, Professional Engineer (B.C.) Conducted a program of reconnaissance geological mapping for United Copper Corporation Limited on the MAE 1 - 4 and SP 1 - 6 mineral claims situated in the Rock Island Lake area of the Kamloops Mining District.

The purpose of this investigation was to determine if sufficiently encouraging geologic indicators of copper mineralizations were present in the claim area.

# LOCATION AND ACCESS

The MAE and SP claims are centered approximately at latitude 51° 33' 10" N and longitude 120° 21' 10" W in the Kamloops Mining District on the Clearwater Map Sheet 92P/9W. The claims lie immediately west of Rock Island Lake, the outflow from which comprises a major tributary of Nehalliston Creek. With altitudes on the claims ranging from 4,300 to 4,600 feet, the area is characterized by a NW - SE trending ridge covered by an open forest of mixed fir and aspen.

Access to the claims is by the Rock Island Lake Jeep road which crosses MAE 3 and 4 claims approximately 1 1/2 miles east of the Friendly Lake road. The Rock Island Lake turnoff is just north of Silver Lake which may be reached by 10 1/2 miles of good gravel road branching from Mile 11 on the Little Fort - 100 Mile House road along Eakin Creek. This new gravel

road climbs steeply up the north side of the valley from a point 1/10 mile beyond the old road, and is marked "Rock Island Lakes 13 Miles". The total distance to the claims from Kamloops is 73 miles.

## SURVEY TECHNIQUES

A fly camp was established along the road on the western side of Silver Lake. Access to the claims was on foot along the Rock Island Lake Jeep road and geological traverses were made in a NW - SE direction at 500 foot intervals along the road.

Numerous cliff-forming outcrops offer good bedrock exposure particularly along the northeastern slopes of the prominent ridge west of Rock Island Lake. Several exposures were mapped along the Jeep road cuts on MAE 3 and 4 claims.

#### GEOLOGY

The MAE 1 - 4 and SP 1 - 6 claims are underlain by a thick, massive sequence of marine volcanics comprising dominantly andesitic augite porphyry breccias with minor andesite and basalt flows. Andesite dikes were observed at two sites near the Jeep road. No plutonic intrusives were noted on the claims.

The entire volcanic sequence has been subjected to broad scale metamorphism of the greenschist facies grade, as expressed



in chloritization of biotite, augite, and feldspars. The andesite dikes are silicified and weakly pyritized; however, the adjacent volcanics show essentially no hydrothermal alteration at the contact.

Outcrop areas mapped during this reconnaissance are shown on the accompanying geologic sketch map. No primary banding and locally, only weak foliation was noted in the volcanic sequence.

The absence of plutonic intrusives, paucity of broadscale hydrothermal alteration, and lack of copper mineralization in outcrops on the MAE and SP claims, indicates only a low probability for the discovery of near-surface economic grade copper deposits.




