



### INTRODUCTION

This report summarizes the results of a Ronka EM-16 electromagnetic survey performed by the writer on the DAVE 3 Fraction mineral claim in the period February 3 - 5, 1975.


The purpose of the geophysical survey was to search for conductor elements on the claimed area as a guide to further mineral development and perform assessment work for the credit of New Minex Resources Ltd.

### SUMMARY AND CONCLUSIONS

Rock outcrops are scarce. Bedrock geology is assumed to be largely Nicola volcanics and related basic intrusives. Phases of the Iron Mask batholith are also believed to underlie part of the claim area. It is known that copper mineralization appears in some cases to occur within or on the flanks of the Iron Mask batholith.

No conductive element of importance was noted on the DAVE 3 Fraction claim.

Current electromagnetic work in progress on adjacent ground may show conductive zones that project into the DAVE 3 Fraction claim. However, since the claim is covered with clay and loam overburden, any interpretation should take this parameter into consideration.

PROPERTY - LOCATION, ACCESS, TOPOGRAPHY

The property is located about five miles south of Kamloops, British Columbia, in Township 19, Range 18, West 6, just beyond the southern limit of the new boundary of the City of Kamloops.

Access is by paved highway (No. 5) to Knutsford and thence via the Edith Lake and Goose Lake gravel roads to Peterson Creek at the location of Morrison Ranches Ltd. The claim area is open ranchland and can be traversed by ordinary automobile under most circumstances.

Open undulating grassland, mostly under grazing lease, characterizes the topography. Elevations vary between 3000 and 3600 feet above sea-level. Snow conditions prevailed at the time of the Ronka EM-16 survey.

PREVIOUS DEVELOPMENT - REFERENCES

A compilation of magnetometer survey work done by D.W. Tully, P.Eng., in January - February, 1973, in the area of DAVE 3 Fraction claim shows a pattern of small local areas having

slightly lower than average magnetic intensity trending north-easterly across the general area of Peterson Creek.

Rolling Hills Copper Mines Ltd. previously filed assessment work on the nearby PAM claims. Vanco Explorations also filed assessment reports on these claims during the 1960's.

## GEOPHYSICAL SURVEY

### GROUND CONTROL

In 1972 McElhanney Associates were retained by Minex Development Ltd. (now New Minex Resources Ltd.) to survey the claim posts in their area of interest around Peterson Creek. A copy of this plan accompanies this report as Key Plan.

A base line was established on bearing  $S35^{\circ}E$  (True) from the southeast corner of L. 4712. This base line is being used for additional current electromagnetic work in the immediate area of DAVE 3 Fraction.

From this base line compass and chain lines were established along bearings  $N55^{\circ}E$  and  $S55^{\circ}W$  over the claim area. Points along the chain and compass lines were marked with flagging.

### INSTRUMENT USED

A Ronka model EM-16, serial number 3329, rented from Geonics Limited, Vancouver, British Columbia, was used in the field work.

### METHOD

First, the instrument was oriented on station NPG, Seattle, Washington, by obtaining as "Null" a position as possible. Readings were then taken in the vertical plane at the "Null" position on both the quadrature and in-phase dials on the instrument, and perpendicular to the primary field.

### RESULTS

The results were plotted on scale 1 inch = 100 feet on the map accompanying this report.


No conductive zone of importance was noted on the DAVE 3 Fraction claim.

INTERPRETATION

Clay and loam overburden overlies most of the claim and should be considered in any interpretation. This is particularly true on the eastern extension of of DAVE 3 Fraction claim in the area of Peterson Creek where a barbed wire fence is also present.

Until results of similar electromagnetic work on adjacent claim areas are available to correlate with the DAVE 3 Fraction results a definitive interpretation of the survey is probably premature.
