INTRODUCTION:

During July 24 to 26, 1976, a total of 25 jade pieces (talus blocks) were tested by packsack drilling (XRPS size). The jade is scattered over the south - facing slope on the "JW" 8 and 9 claims. Drilling was done by M.Kaaremaa and K.Makepeace, drillers, and core was examined later by the writer. Because all core was poor quality, greyish green talcy jade, no detailed logs were made, and no attempt was made to tabulate the exact location or azimuth of each hole. The general location of the drilling area is shown on the accompanying maps.

Cores are stored by Nephro - Jade Canada Ltd. at their office in Vancouver, at 200 - 3540 W. 41 Avenue.

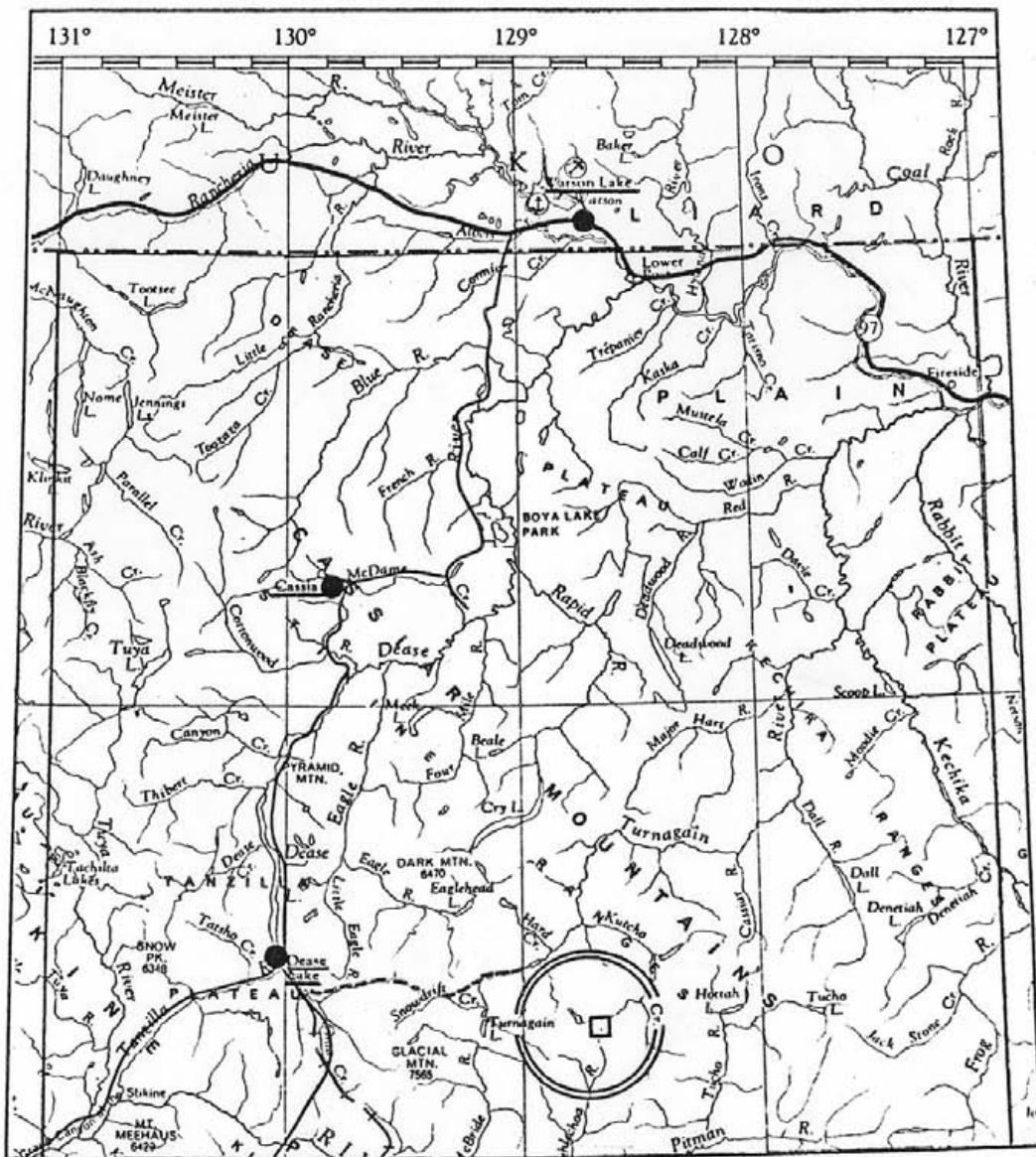


FIG. 1. Location map of Dease Lake - Watson Lake area. Large circle outlines Provencher Lake area. Scale: 1 in = 30 mi.

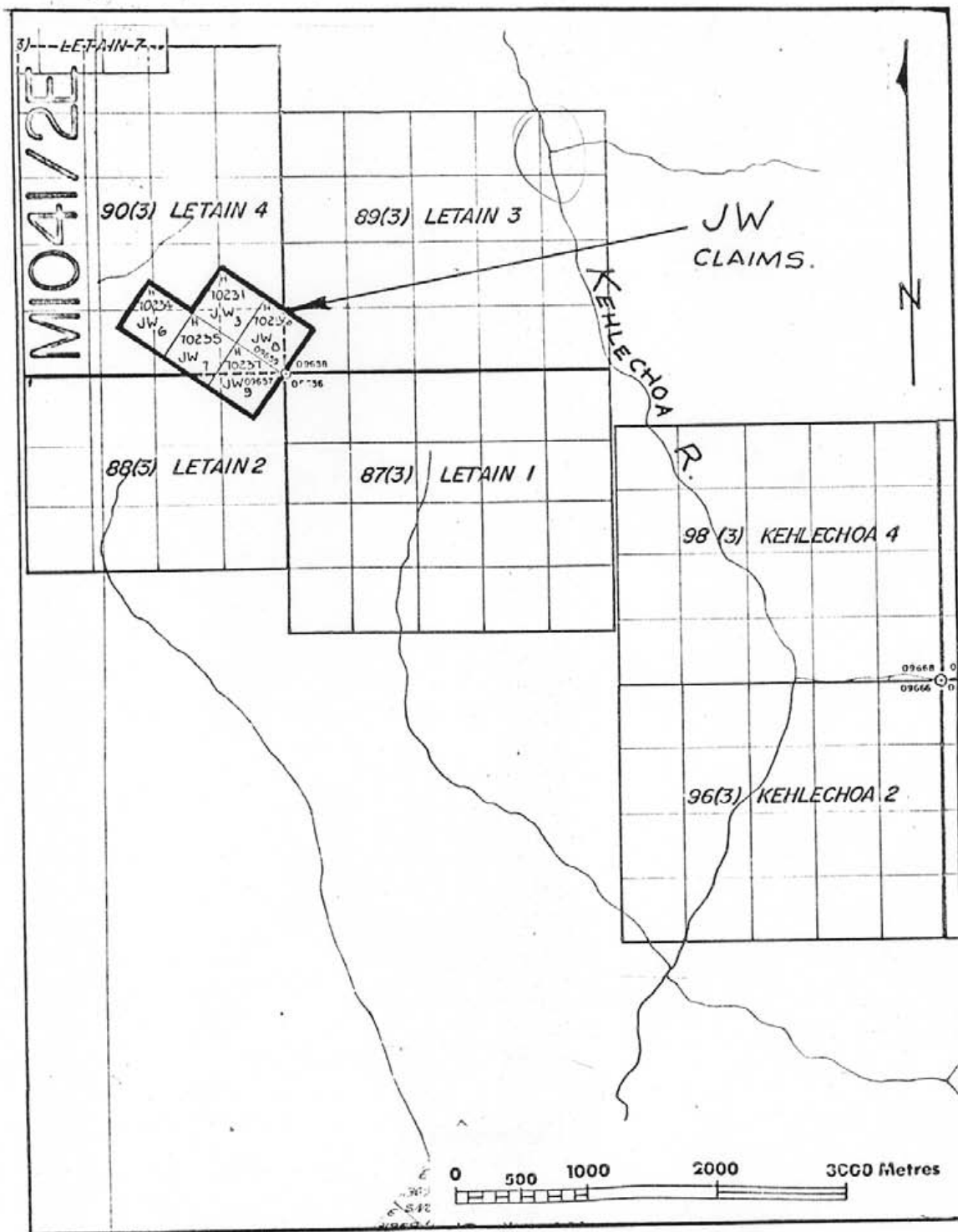
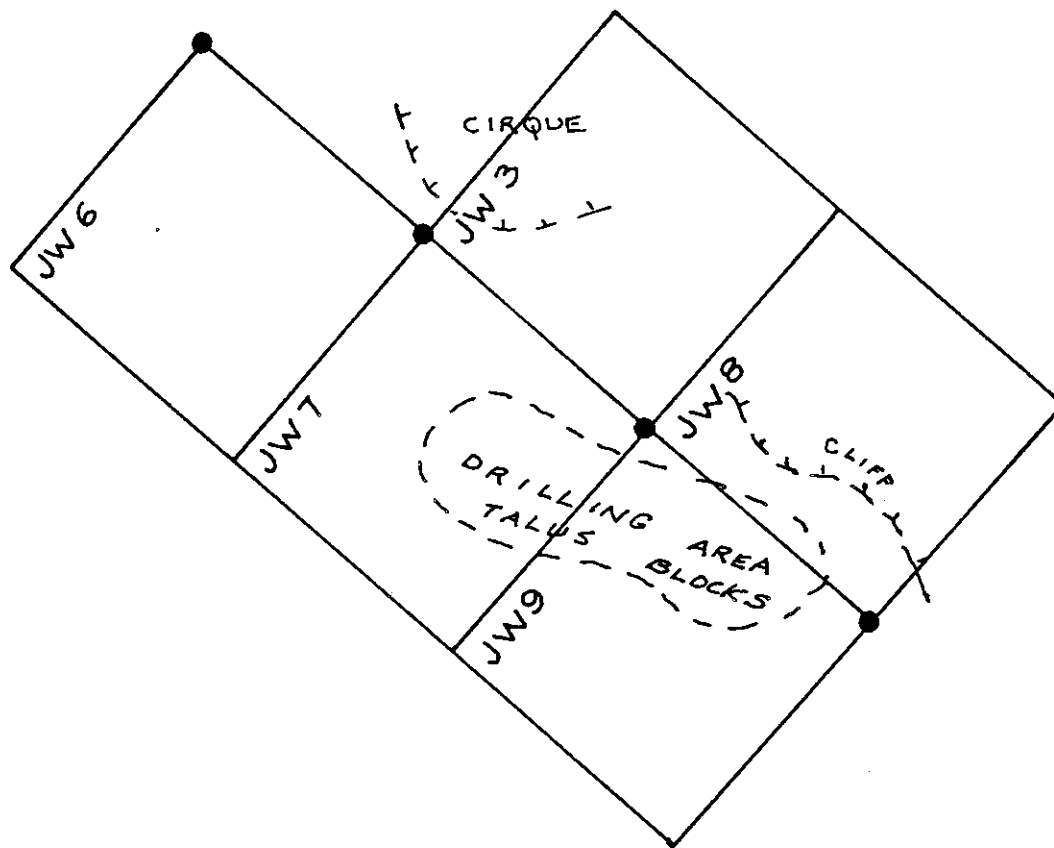


FIGURE2; Portion of claim map 104 I 2E showing "JW" claims.
