LOCATION OF THE PROPERTY:

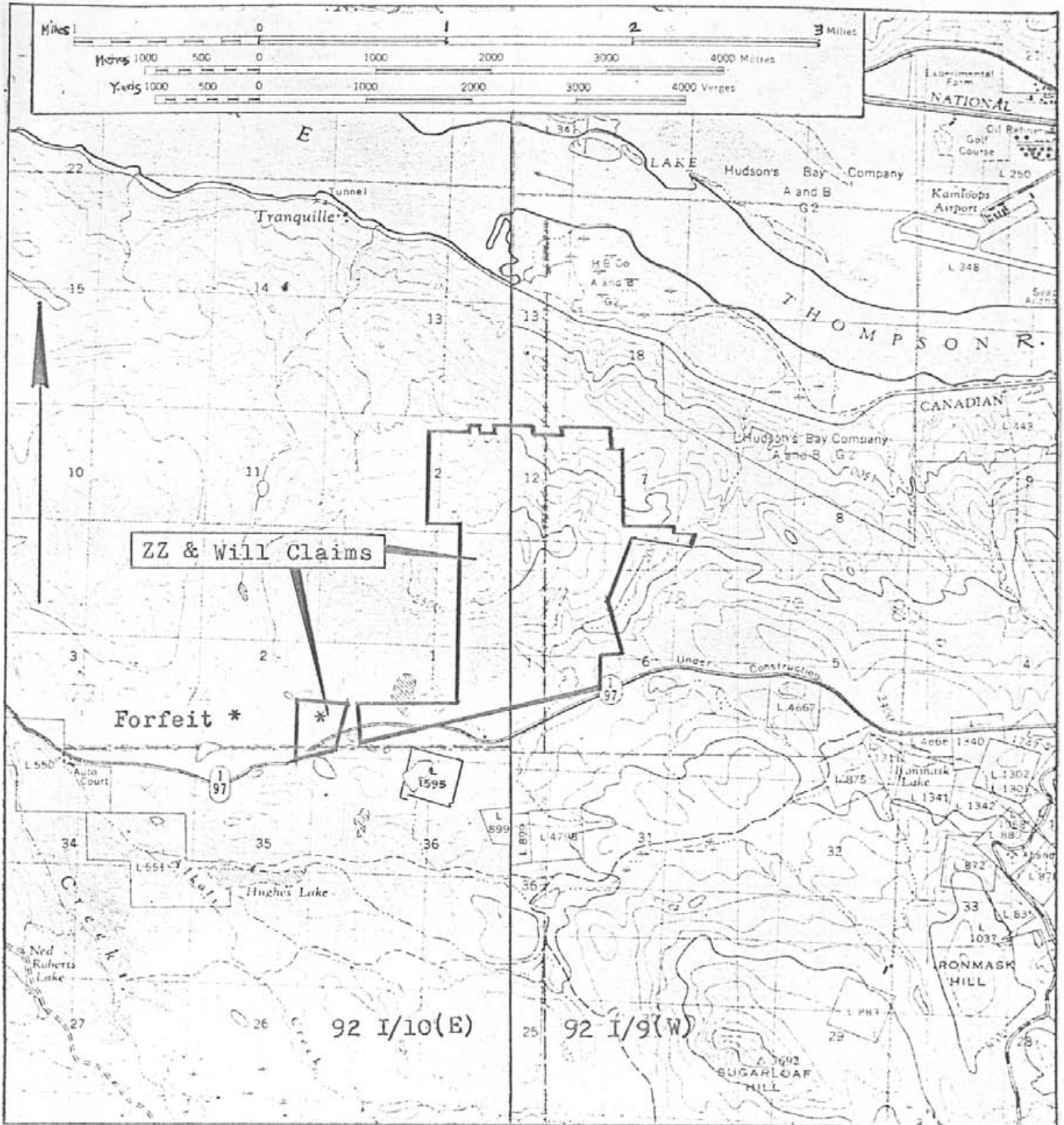

ZZ & Will Claims

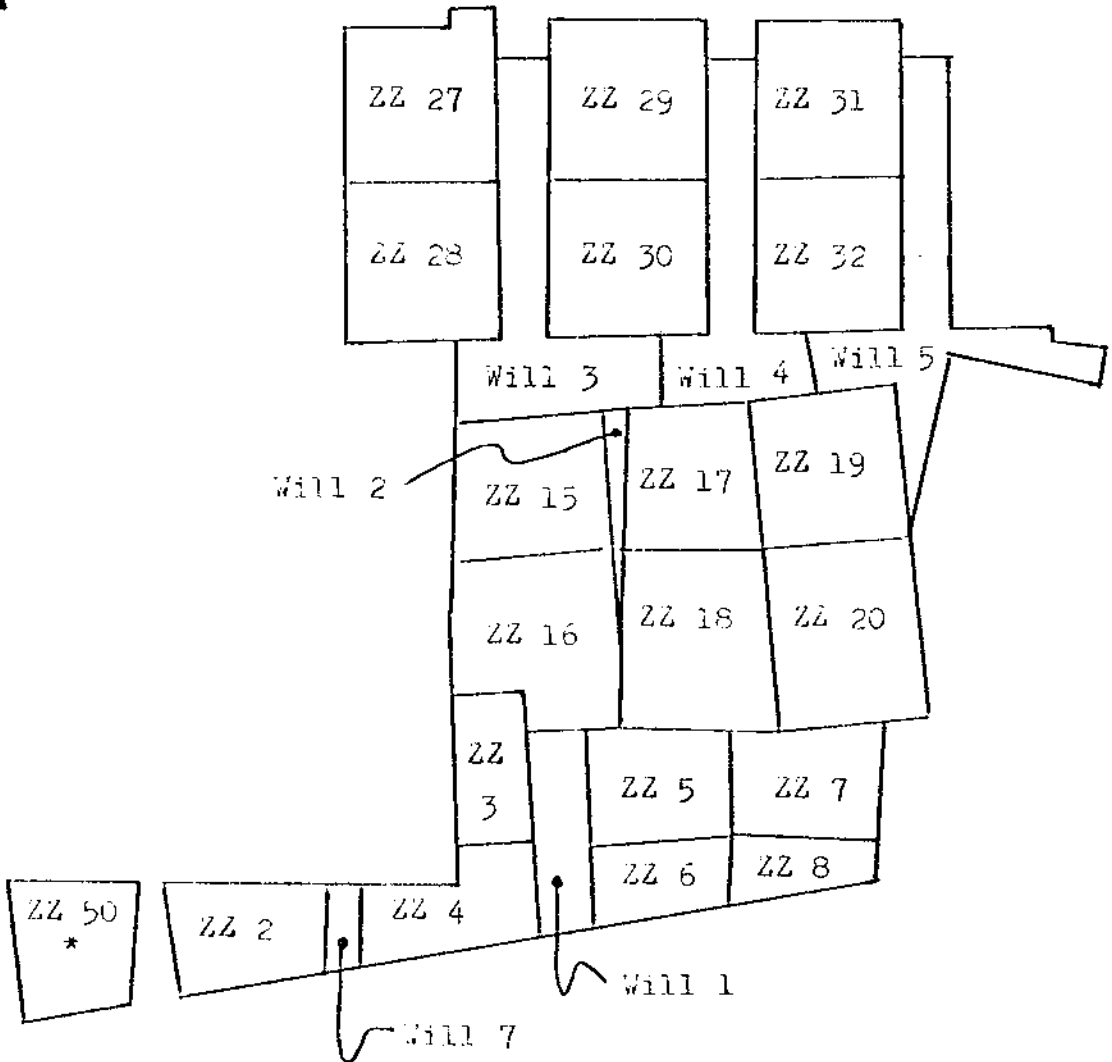

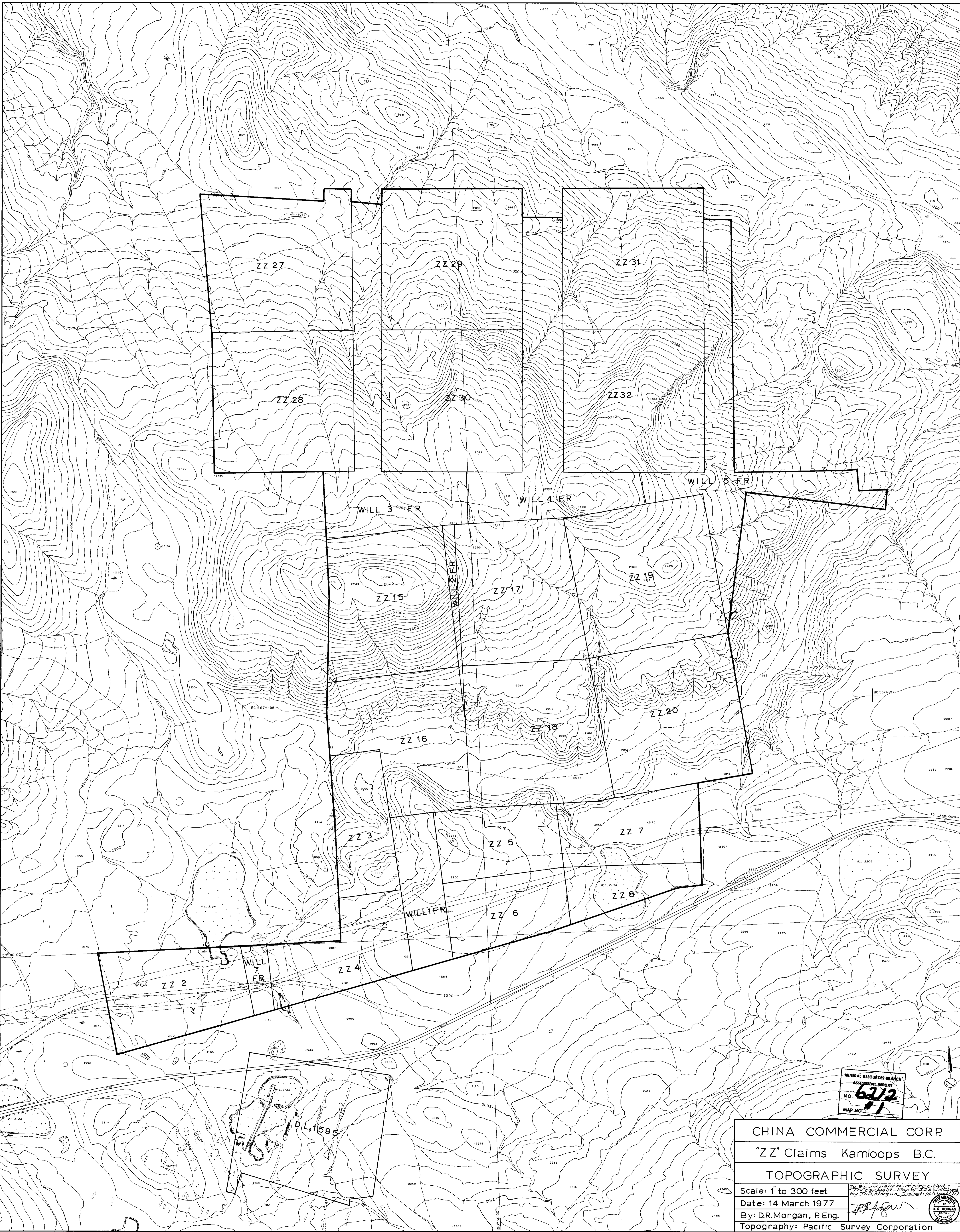
