A. PREFACE

Work for which assessment credit is requested on the PARMAC 1 mineral claim consisted of topographic mapping and road building. Road building was undertaken during the period March 23, 1977 through April 2, 1977. Topographic mapping was completed on March 31, 1977.

This report is a compilation of this work.

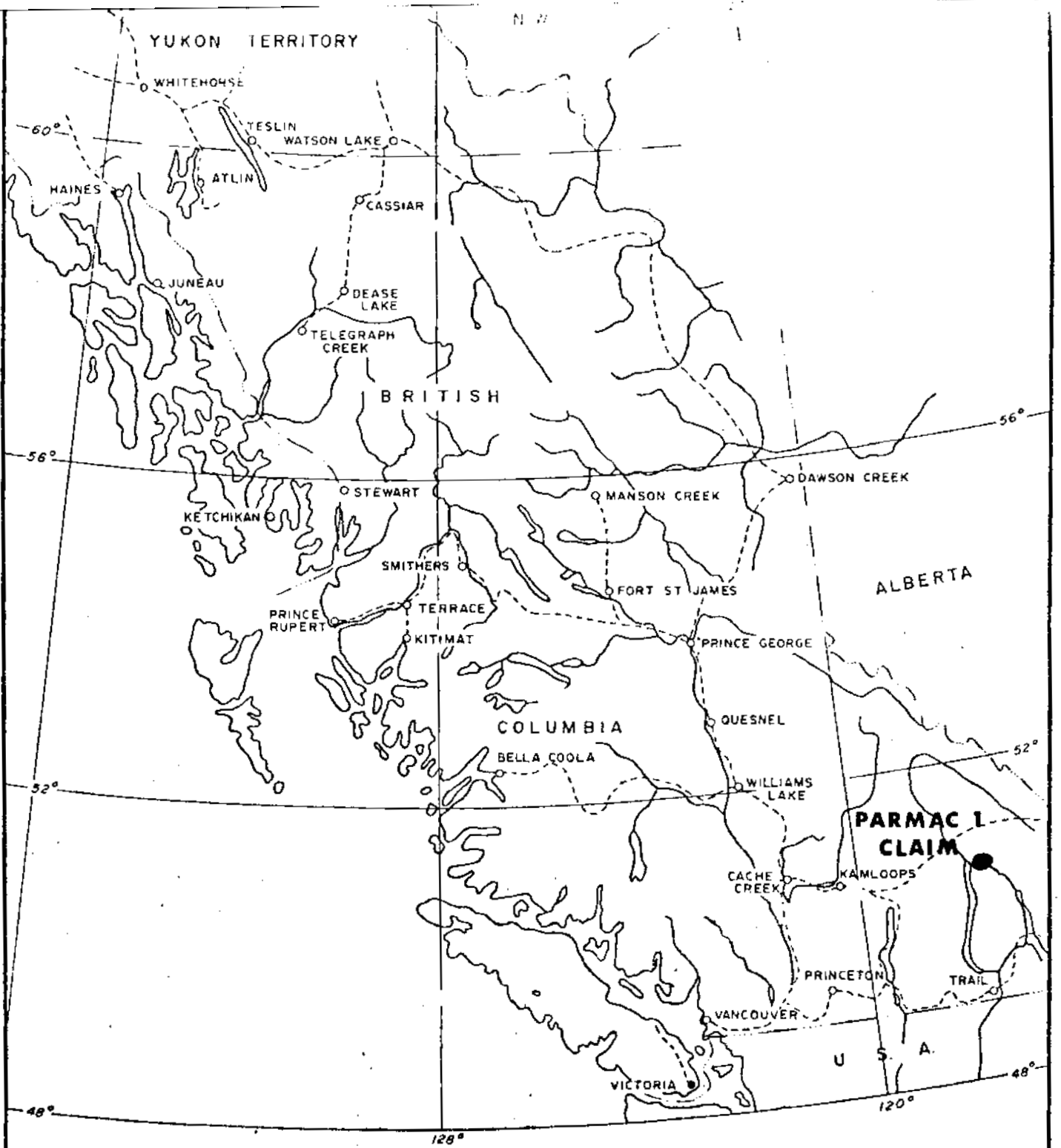
As a result of the work performed, assessment credit is requested on the PARMAC claim as follows:

## B. OBJECTIVES OF WORK

Topographic mapping and road construction were undertaken to facilitate detailed structural and geological mapping of the PARMAC 1 claim during the 1977 field season. Both the road and topographic map are necessary and a direct adjunct to geological mapping and probable drill planning.

## C. LOCATION AND ACCESS

The PARMAC 1 claim is located, approximately 32 kilometers southeasterly from Revelstoke in the Revelstoke Mining Division, on NTS 82K/13W.

Access to the claim is by taking the all weather road leading from Revelstoke on the east side of the Columbia River for 19.2 kilometers (12 miles) thence travelling easterly on the Akolkolex River logging road for 15.7 kilometers (9.8 miles). At this point a new 4-wheel drive road has been constructed which leads north for some 1,000 meters into the central portion of the PARMAC 1 claim.

## D. ROAD CONSTRUCTION

United Mineral Services Ltd. under contract to Cyprus Anvil Mining Corporation and Metallgesellschaft Canada Ltd. constructed a 4-wheel drive road into the central portion of the PARMAC 1 claim from the Akolkolex River logging road between March 23, 1977 and April 2, 1977. Twenty-five hours of HD-6 cat work were required. A previously existing but overgrown and washed out tote road and trail system was used as a base for the new one kilometer long 4-wheel drive road. The location of this road is shown herein as Figure 2.

## E. TOPOGRAPHIC MAPPING

McElhanney Surveying and Engineering Ltd. constructed a 1:10,000 scale topographic map of the PARMAC 1 claim area using existing air photography between March 3, 1977 and March 31, 1977. Contour interval of the map is 20 meters. The topographic map labelled Akolkolex River is found in the back pocket of this report and it is keyed to Figure 2 which shows the accurate location of the surveyed area relative to the PARMAC 1 claim and identifiable geographic features.



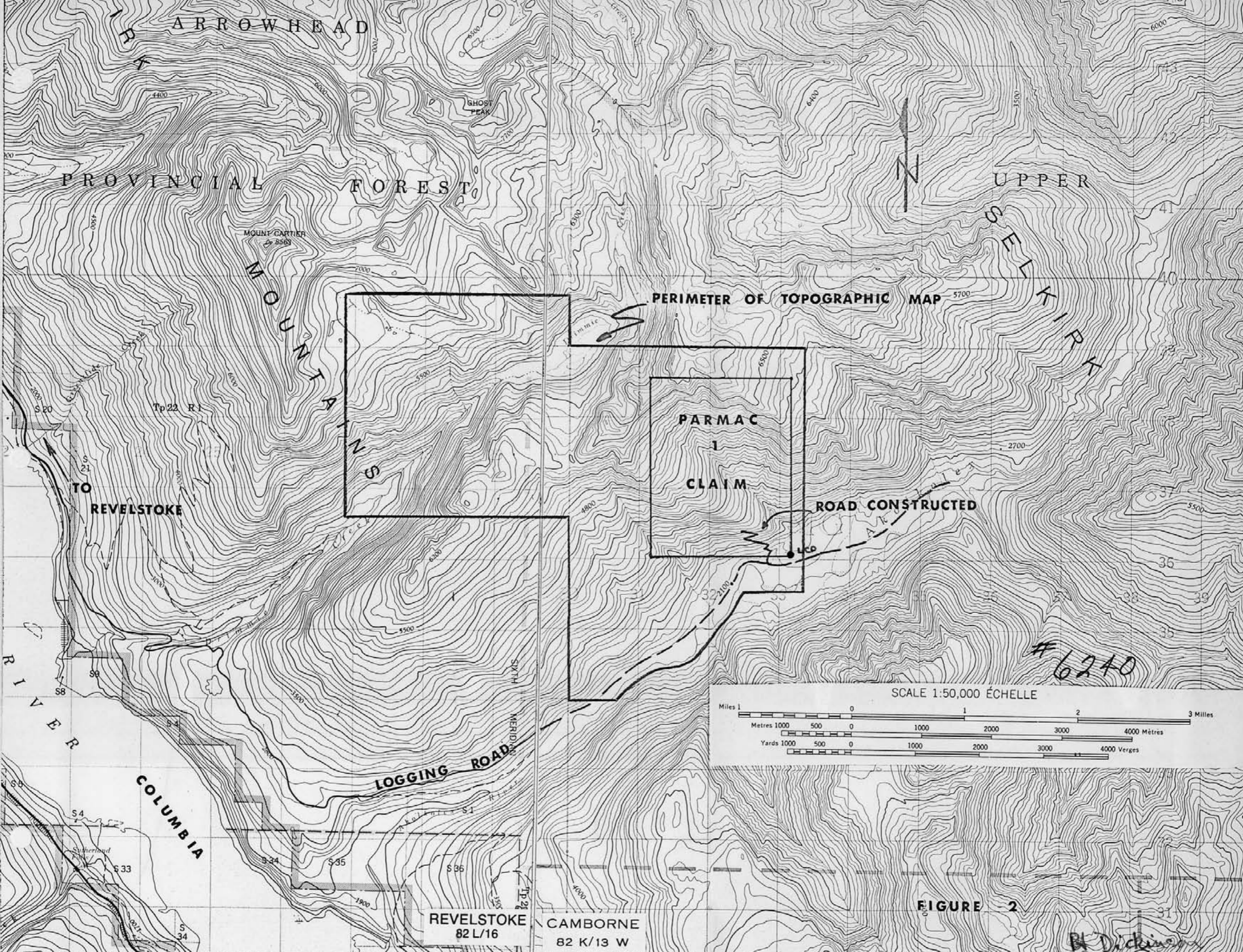


Together with Metallgesellschaft Canada Ltd., Cyprus Anvil Mining Corporation have recently negotiated an option on the PARMAC #1 claim and adjoining BIG R and BIG M claims from Mr. Mel Pardek and Parmac Mines Ltd.

We note that the due date for the PARMAC #1 claim is 5 April, 1977. As no meaningful fieldwork will be possible before this date and as the primary requirement for the area is a detailed structural and geological map, we will be contracting a 1" to 1,000 ft., 50 ft. contour topographic line map, using existing air photography. This work will be a necessary and direct adjunct to geological mapping and on-going drill planning. 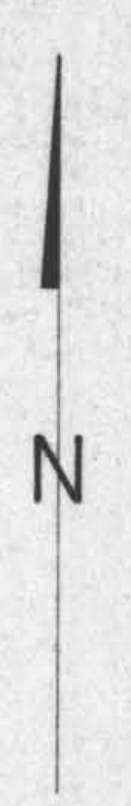

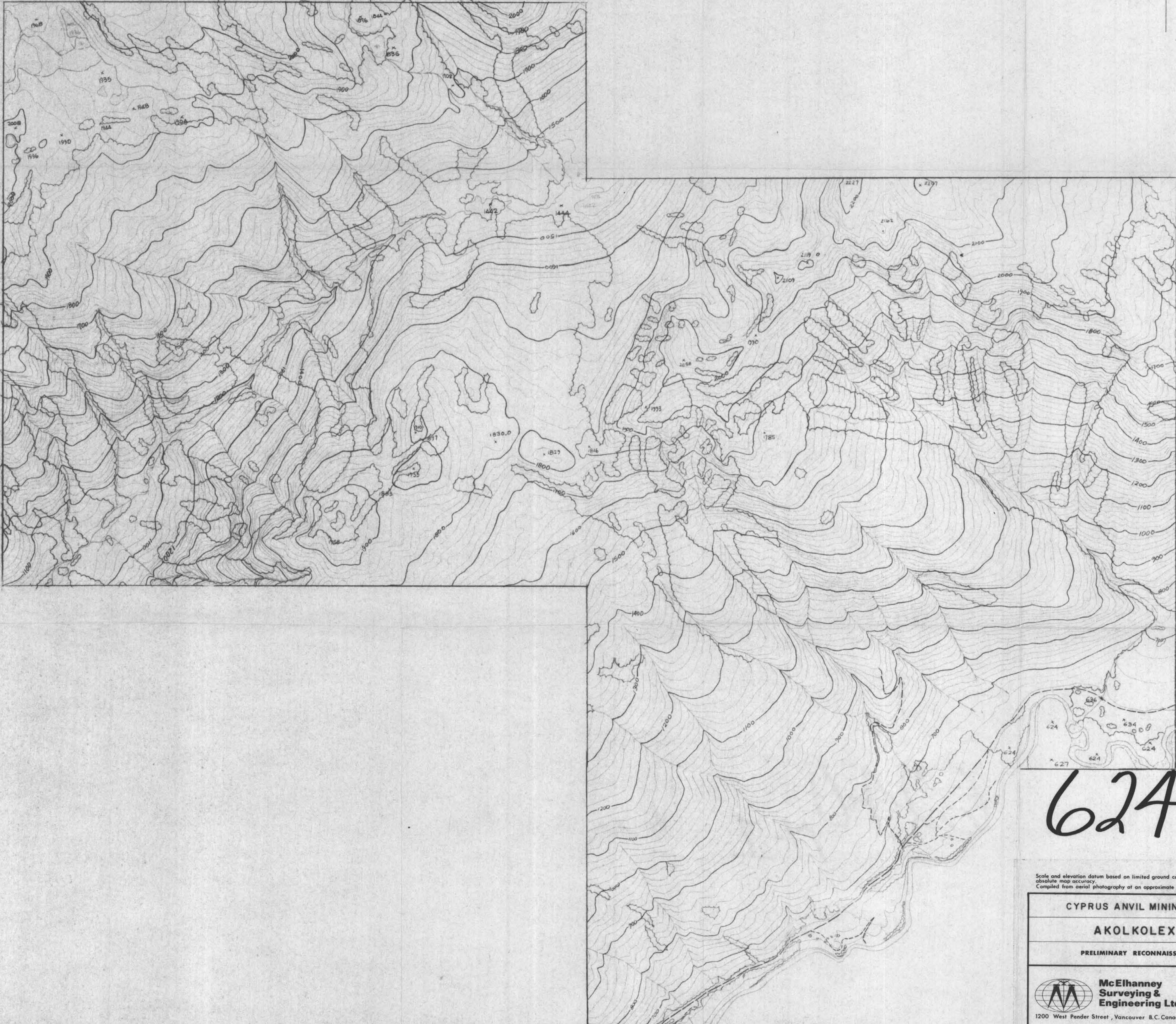
