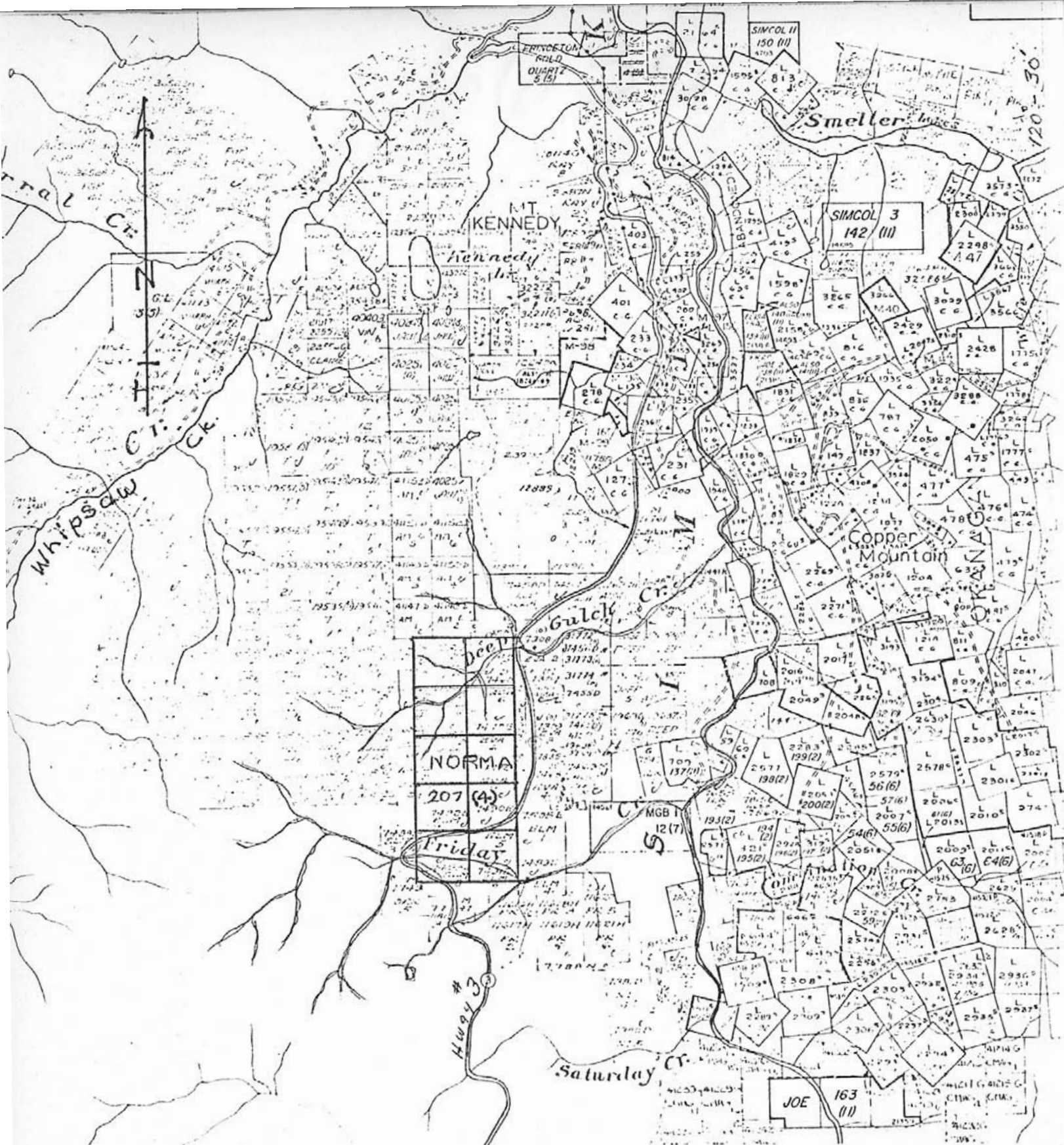

PROPERTY MAP

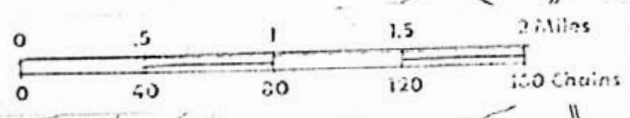

INTRODUCTION

Soil samples were taken from the Norma claim at the "B" horizon of overburden, and assayed for copper.

The samples were taken over a surveyed grid at 100 metre intervals on east-west lines at 150 metre spacing. Over the northern two-thirds of the property, additional lines were located at 75 metre spacing.

Field work by Alfred R. Allen, P.Eng., Thomas Thomas and Richard Thomas was started November 1, 1977 and completed December 8, 1977.

Base of operations was Princeton, B.C.

LOCATION AND ACCESSIBILITY

The Norma claim is located on the west side of the Hope-Princeton Highway between Friday and Deep Gulch Creeks, 15 miles southerly from Princeton.

This is $120^{\circ} - 34'$ west longitude and $49^{\circ} - 18'$ north latitude, about 4 kilometres southwesterly from Copper Mountain.

PROPERTY

The Norma claim legal corner post is 2,500 metres north of Friday Creek, and 60 metres west of Highway #3.

The metal tag attached to the post is #35043.

The claim is 5 units south by 2 units west.

It was staked by John Turner, March 7 and 8, and recorded March 17, 1977. It is designated as #207 on the B.C. Ministry of Mines and Petroleum Resources Map #92 H - 7 E.

HISTORY

J.W. Galagher prospected and staked the area in 1952.

Deep Gulch Mines held it in the late 1950's.

In 1968, Oro Mines acquired the property and completed some geophysical investigations, trenching and drilling.

Gilford Resources Ltd., purchased the Norma claim in the summer of 1977.

GEOLOGY

Exposures of the Copper Mountain intrusives lie close to the east boundary of the Norma property.

Most of the claim is underlain by Nicola volcanics but a capping of Princeton volcanics is located on the southerly portion.

The Nicola rocks are altered, faulted and sheared.

Quartz veins and pyritized sections have been exposed by trenching.

TOPOGRAPHY

The property lies between elevations 3,700 and 4,800 feet above sea level on the northeast slopes of Friday Mountain.

Friday and Deep Gulch Creeks flow easterly and northeasterly across the property and into the Similkameen River.

GRID CONTROL

A grid was surveyed by chain and Brunton compass over the property. A base line was located along the east boundary and west lines were run every 150 metres to the west boundary. Intermediate lines were located at 75 metre intervals over the north two-thirds of the area. Stations were established at 50 metre intervals along the lines.

Lines were blazed and flagged and stations were marked with location numbers.

The grid is shown on the accompanying map #2 on a scale of 1cm = 50 metres.

GEOCHEMICAL SURVEY

From each grid station a sample of soil was acquired from the "B" horizon. Each sample was placed in a heavy paper sample envelope. Each envelope was marked with the date, grid location number and sampler.

Over 26.5 line kilometres, 268 samples were taken.

The samples were dried, screened to -80 mesh and assayed for copper by acid extraction and atomic absorption in the General Testing Laboratories, 100 East Pender Street, Vancouver, B.C.

Sample results are included with this report and shown on the accompanying map #3.

SURVEY RESULTS

The copper content of 264 soil samples taken over the Norma claim averaged 16.6% parts per million copper.

The samples are classified as follows:

Anomaly #1.

On the northeast corner of the property, an area covered by overburden.

Range 72-80 p.p.m. copper

Anomaly #2.

100 x 150 metres on the east boundary at 6+ 75 S.

Trenches to the south at 11+ 75 S. expose strong alteration, faulting, silicification and pyritization.

Range 41-86 p.p.m. copper

Anomaly #3.

A "spot" sample of 45 p.p.m. copper at 10+ 50 S on the east boundary.

Trenching at 11+ 25 S expose strong alteration, faulting, silicification and pyritization.

Anomaly #4.

A "spot" sample of 57 p.p.m. copper at 7 W on line 4 + 50 S.

Anomaly #5.

A "spot" sample of 50 p.p.m. copper at 9 W on line 11 + 25 S.

Anomaly #6.

A "spot" sample of 47 p.p.m. copper at 6 W on line 22 + 50 S.

Anomaly #7.

A "spot" sample of 48 p.p.m. copper at 7 + 50 W on line 8 + 25 S

Anomaly #8.

A "spot" sample of 50 p.p.m. copper at 5 W on line 6 S.

These anomalies are surrounded by areas of minor copper content - (20 - 39 p.p.m. copper).

SUMMARY AND CONCLUSIONS

The Norma property is located southwesterly from the Similkameen mine and the former Copper Mountain mine.

The northerly three-fifths of the area of the property is underlain by the Nicola group of volcanic rocks and the remaining two-fifths to the south, is capped by Tertiary volcanic rocks of the Princeton Group.

Strong alteration and heavy faulting is exposed by trenching near the east boundary in the andesitic Nicola rocks. In addition, quartz veins, silicification, and pyritization is evident in the trenched areas.

Anomalous zones 1, 2, 3, and 5 appear to warrant further investigation.

It is concluded that stripping and trenching to expose bedrock will be necessary to assess the anomalous zones, and that no additional soil sampling is necessary.
