INTRODUCTION

The SATURDAY claim, Lot No. 2043, S.D.Y.D., is a single reverted Crown-granted mineral claim comprised of 37.40 acres.


GEOGRAPHIC LOCATION

The Saturday claim is located 1.5Km West of Hedley, B.C. on the North side of the Similkameen River. Highway #3 runs E-W through the property.

ACCESS TO CLAIM

Access to the Saturday claim is via the #3 Highway, 1.5Km west of Hedley. The roadside pull-out with the garbage disposal marks roughly the centre of the claim.

PROSPECTING REPORT

AREA PROSPECTED

The area prospected is roughly in the centre of the claim. The area of particular interest is 100m x 150m, where a green andesite porphyry dyke outcrops, cutting Nicola Group country rocks. The dyke and the contact zones were examined and sampled.

MINERALS SOUGHT

Gold was the mineral prospected for, as it is known to occur widespread throughout the Hedley area. and particularly adjacent to dykes, sills, and other intrusive bodies.

CONCLUSIONS

The dyke contains no gold itself but areas immediately adjacent to the dyke contained minor gold values.


