**SUMMARY OF WORK**

**INTRODUCTION:**

The Mod Bar Cu-Au-Mo property consisting of 53 claim units is located some 11 km southeast of Boston Bar in the Cascade Mountains. The claims are owned or controlled by Mr. K.W. Livingstone and Mr. J.S. Christie of Vancouver.

In June 1984, the Nicola Prospecting and Mining Syndicate undertook to carry out a program of geological mapping and geochemical sampling in order to assess the gold potential of the property.

**LOCATION AND ACCESS:**

The Mod Bar property is located 11 km southeast of Boston Bar, B.C. in the New Westminster Mining Division. The property lies south of Uztlius Creek, at elevations 750 to 1070 meters. The claim group is accessible by logging roads leading east out of Boston Bar, or east from the Alexandra Bridge. Clear cut logging is in progress over the newly staked eastern portion of the claim group and new logging roads are being constructed.

The property location is shown on drawing nos. MB-84-1 and MB-82-2 which are appended in Section E.

**MINERAL TITLE**

The property is comprised of eight (8) mineral claims totalling 53 units, all being located in the New Westminster Mining Division. A listing of these minerals claims is set out below:

These mineral claims are shown on drawing MB-84-2 which is appended in Section E.

HISTORY:

- August 1969 - Property originally staked as the Mod-Bar group south of Uztlius Creek, first with 70 claims then expanded to 277 claims.
- 1975 - Quintana Minerals Corp., staked the CUC 1-24 group and carried out a geological mapping program. Previously five diamond drill holes totalling 1732.5 feet were drilling under the supervision of J.H. Montgomery, P. Eng.
- 1979 - Utah Mines Ltd. using JMT Services conducted a reconnaissance geochemical soil and rock sampling program over the property. Cu and Mo anomalies were located.
- 1982 - JMT Services extended the 1981 soil grid and collected 54 soil samples which were run for Cu and Mo.

GEOLOGY:

Regional Geology:

The regional geology for the area is published as G.S.C. Map 12-1969 "Hope" (sheet 92H West Half). The eastern side of the claims are underlain by Eagle granodiorite of Upper Jurassic age which is in probable fault contact with the Jackass Mountain Group. The Spences Bridge Group (predominantly acid to intermediate volcanics) and the Kingsvale (mafic to intermediate flows and sediments) are approximately time equivalent groups which are mapped east and north of Uztlius Creek.

Property Geology:

The claim group is underlain by a sequence of intermediate to acid volcanic rocks spatially located between the Jackass Mountain Group conglomerates on the west and Eagle Granodiorite stock to the east. To the south a variety of intrusive rock types cut sediments which have been selectively hornfelsed. Young sediments with fragments of rhyolite, hornfelsed sediments and tuffs intrude hornfels adjacent to a weakly mineralized granodiorite stock.

Rock Types:

Eagle Granodiorite - the granodiorite is gray, weakly foliated equalgranular with gneissic varieties showing weak pervasive chlorite alternation of the biotites.

Jackass Mountain Group - represented by conglomerates composed of dark massive greywacke with local slabs and pebbles of black argillite and greywacke.

Volcanics - the core of the claims are underlain by rhyolites, dacite porphyries and rhyolite tuffs in contact to the west with a belt of carbonaceous tuff, conglomerates and rhyolite tuff.

North Zone:

The North Zone is underlain by a quartz eye porphyritic rhyolite lying between a black tuff and the Eagle Granodiorite. Relic flow banding give an apparent attitude of N40°E with a dip of 10°SE. Pyrite is abundant where fracturing is most intense and narrow sericite envelopes are often developed on the pyrite infilled fractures. Several feldspar porphyry dykes of monzonite composition intrude the rhyolite flows and contain 2-5% disseminated and fracture pyrite with a trace of chalcopyrite. A small breccia pipe with the rhyolite porphyry carries 1% fracture pyrite within sericitic envelopes.

South Zone:

The South Zone straddles the contact between a hornfelsed siltsone or tuffaceous siltstone and the porphyritic rhyolite. Fracture controlled pyrite in the hornfels, increases to 5 - 10% adjacent the rhyolite contact. A breccia pipe some 200 feet in diameter occurs within the rhyolite and contains 5-10% pyrite as both fracture filling and disseminations. Phyllitic alteration is extensive within the breccia pipe and the adjacent 200 ft. of rhyolite to the east. Feldspar porphyry dikes of monzonite composition intrude the rhyolite and hornfels and generally contain disseminated pyrite in the hornblende laths.

ROCK GEOCHEMICAL SURVEY:

In June 1984, the writer visited the North Zone and sampled rock exposures revealed in the shoulders of old mining roads located along the ridge south of Uztlius Creek. The roads cross cut the contact of a leucocratic quartz eye rhyolite porphyry and the western margin of the Eagle granodiorite. Past soil sampling by previous claim owners indicated areas of above background molybdenum values in the rhyolite rock units. Minor quartz veining was observed but not previously sampled for gold or silver.

Eight multiple rock chip samples were collected from selected exposures along the old mining roads and were sent to Chemex Labs Ltd., 212 Brooksbank Avenue, North Vancouver, B.C. The sample sites were selected from zones of stronger quartz stockwork veining, silicification, alteration and sulphide mineralization. Multiple chip samples from fresh rock exposures were taken at each sample site. The samples were prepared by Chemex Labs with silver geochemical values being measured by atomic absorption after an aqua regia digestion. The gold values were obtained by conventional fire assay with an atomic absorption finish.

The description of the samples whose location is shown on drawing no. MB-84-3 is as follows:

<u>Sample Number</u>	<u>Description</u>
MB #1	A 2 cm bull quartz vein striking N 62° E and dipping 40° SE cuts a massive leucocratic quartz eye rhyolite porphyry.

- MB #2            Taken at the contact with the Eagle granodiorite this sample is of silicified and pyritized, sericite altered very fine grained altered rhyolite
- MB #3            Grab samples from a road trench cutting silicified and pyrite flooded (approximately 4%) rhyolite porphyry.
- MB #4            Multiple chip of a leucocratic, silicified quartz eye rhyolite porphyry. Minor specular hematite and pyrite veining observed. The rhyolite was cut by a fine quartz stockwork.
- MB #5            Multiple chip of a 1 cm open fracture containing fine crystals of pyrite and specular hematite. The wall rock is unaltered quartz rhyolite porphyry with minor quartz veinlets.
- MB #6            Multiple chip of unaltered quartz rhyolite porphyry cut by a fine stockwork of tight quartz pyrite veinlets.
- MB #7            A border phase of leucocratic quartz eye latite which has been tectonically brecciated and micro shattered. Rock contains open fractures and fine disseminated pyrite (3%).
- MB #8            Sample from a trench which exposes leucocratic unaltered quartz rhyolite porphyry which has been quartz veined and contains quartz pyrite healed fractures.

The gold and silver values for the above rock geochemical samples are appended in Section D.

### SOIL GEOCHEMICAL SAMPLING:

In August 1984 a soil geochemical sampling program was conducted over claims in the east central portion of the claim group. The program was contracted out to JMT Services Corp., of Vancouver, who supervised the sample collection.

Samples were collected on a grid tied into intermediate claim posts on the MB #5 and Mod claim groups. Samples were taken every 50 meters on east-west lines spaced 100 meters apart. Control tie lines were run on a 500 meter spacing. The soil samples were collected about 5-20 cm in depth from the interface between the organic A and B horizon. Organic residue from the A horizon was removed from the samples before bagging. Three hundred and eighty-two (382) samples were collected on 18,900 meters of grid line.

### Sample Treatment

The soil samples were collected in Kraft bags and dried. A portion of the 80 mesh size was digested with a solution of nitric-perchloric acids. The copper and gold values were measured by atomic absorption. The geochemical assays were done by Chemex Labs Ltd., 212 Brooksbank Avenue, North Vancouver, B.C.

### Geochemistry Results

Copper - Copper values range up to 275 ppm. Background is approximately 30 to 50 ppm. Those values over 200 ppm are considered anomalous. The 1984 copper soil survey contained only a few anomalous copper values which were not contiguous. The area appears to have a low copper background with little evidence of anomalous concentrations of copper.

Gold - Gold values range up to 93 ppb. Background values are less than 2 ppb. Those values over 10 ppb are considered anomalous. Spot anomalous gold geochemical values occur throughout the grid sampling and further follow up is necessary to assess their importance.

### CONCLUSIONS AND RECOMMENDATIONS

In the North Zone on the ridge just south of Uztlius Creek, the sampling of the quartz veins cutting the quartz-eye porphyritic rhyolites adjacent the Eagle granodiorite stock indicates the veins have little precious metal potential. The area is slightly anomalous in copper and molybdenum (see 1982 Geochemical Report on the Mod Bar Property by J.S. Christie), but economic concentrations of these metals have not been found in bedrock.

On the MB #5 claim the copper values are low with only a few spot highs. No consistant anomaly is indicated. The anomalous gold values are also widely distributed, but their significance can only be assessed by further detailed soil and rock sampling and geologic mapping.




