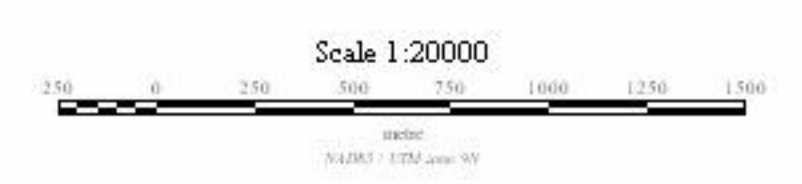
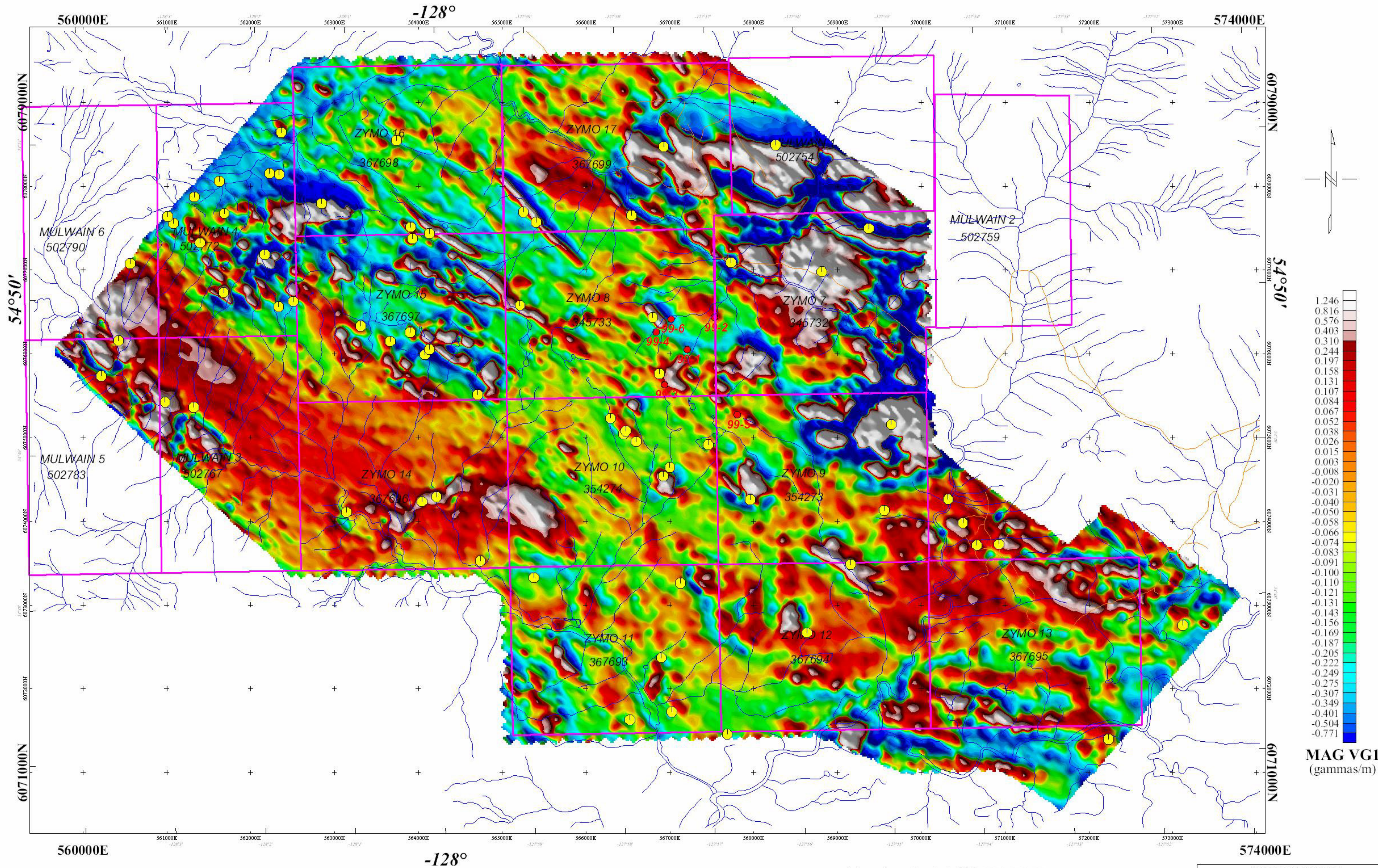


TOTAL FIELD AEROMAGNETIC SURVEY


Contour Intervals: 20, 100 & 500 gammas

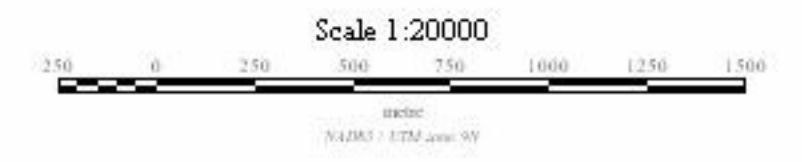

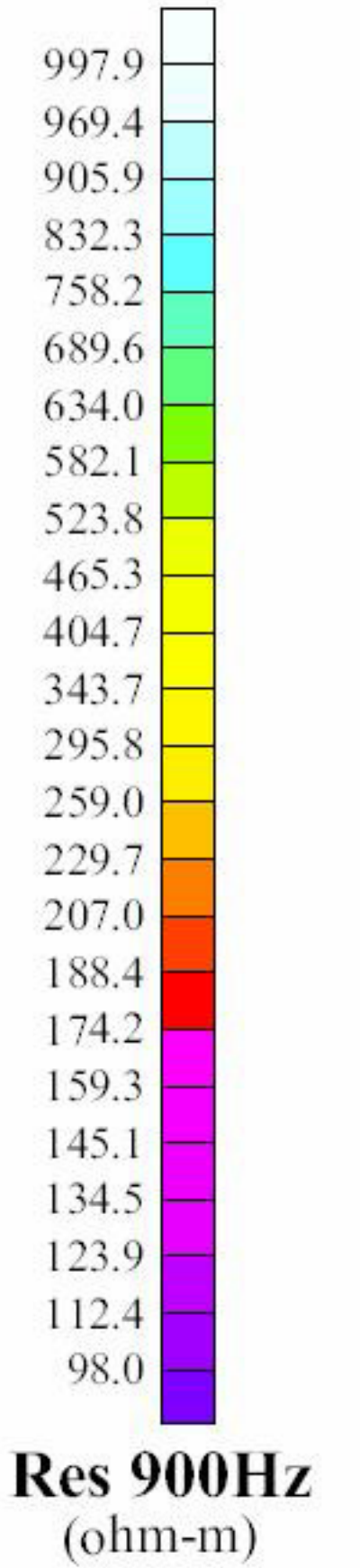
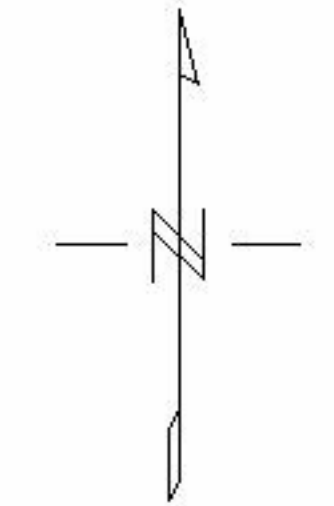
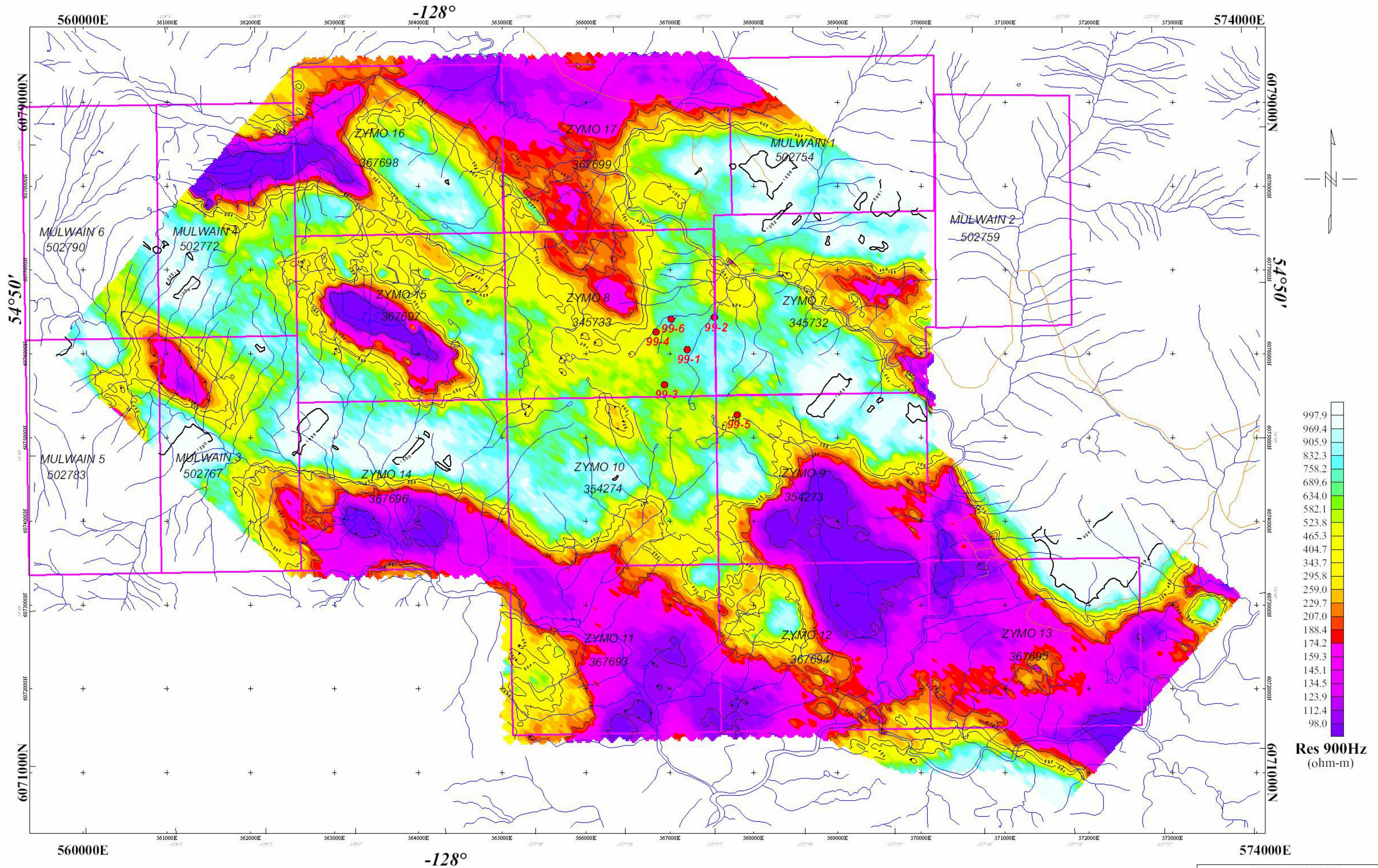


CALCULATED VERTICAL MAGNETIC GRADIENT

 Contour Intervals: 0.2, 1.0 & 5.0 gammas/m

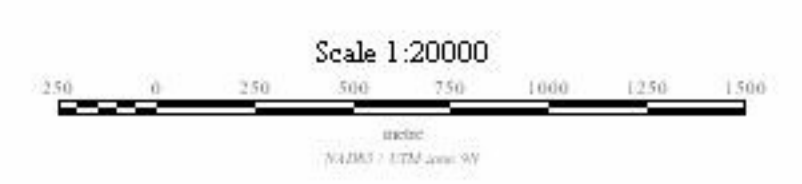

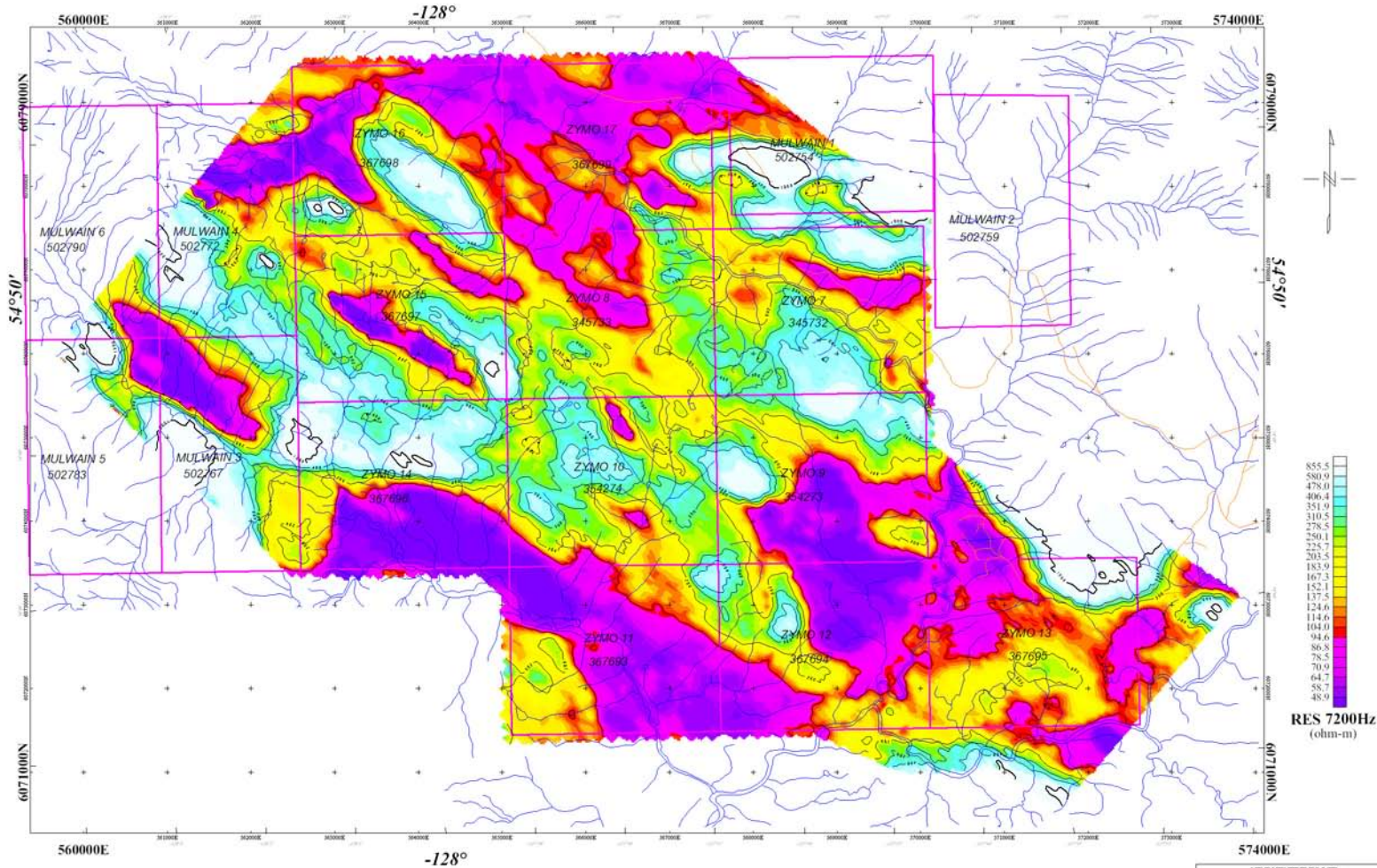

900 Hz Coplanar Apparent Resistivity



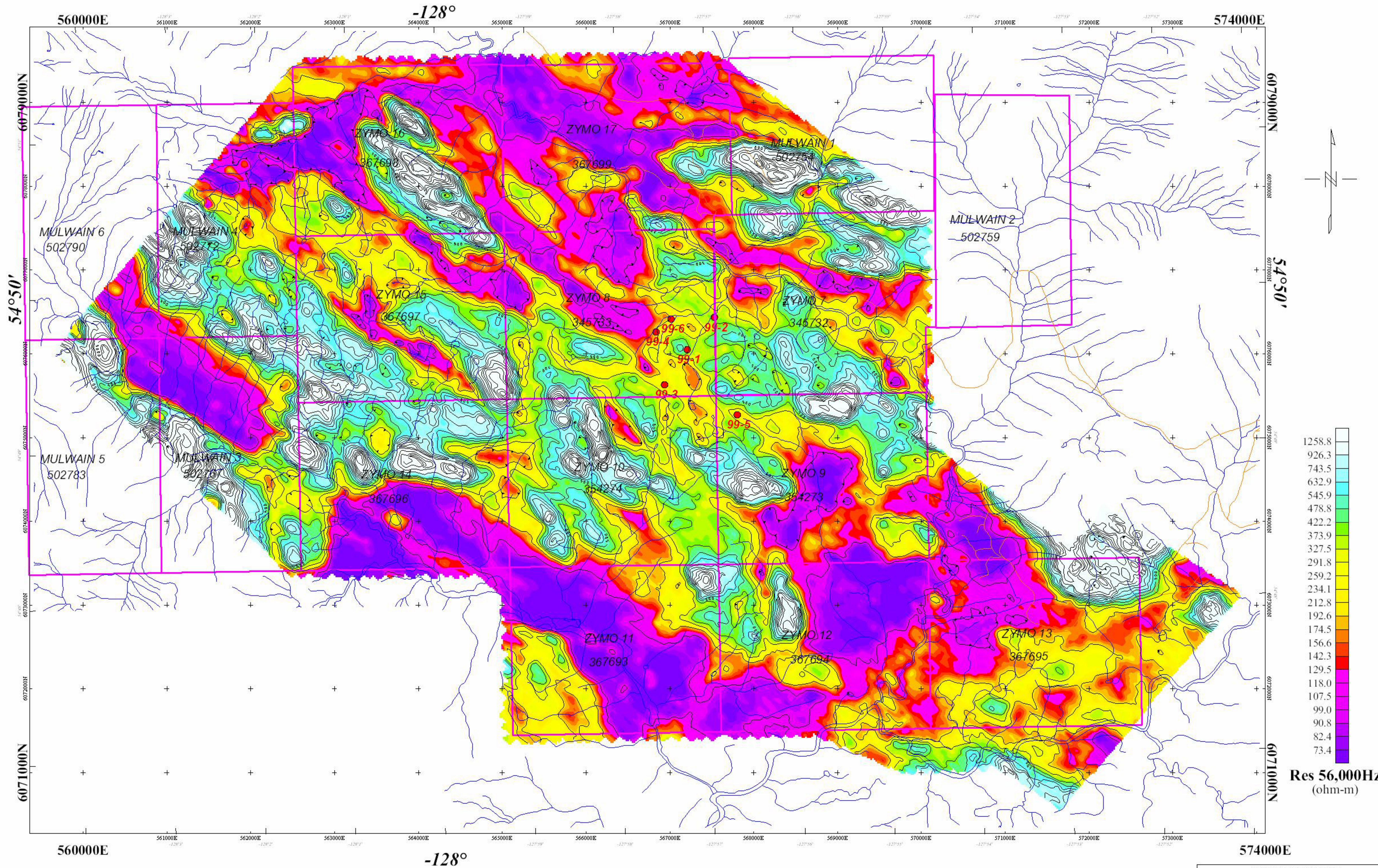

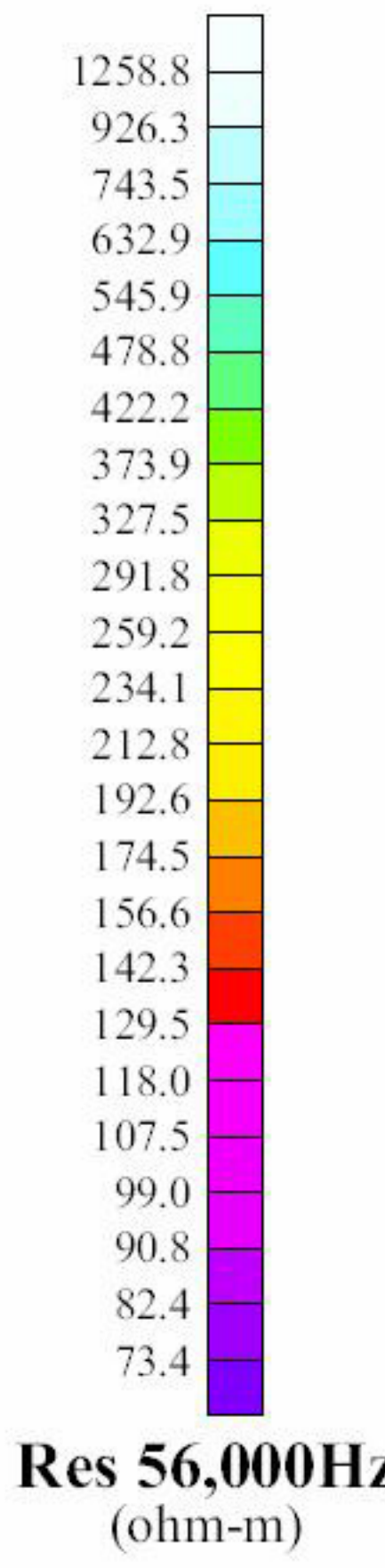
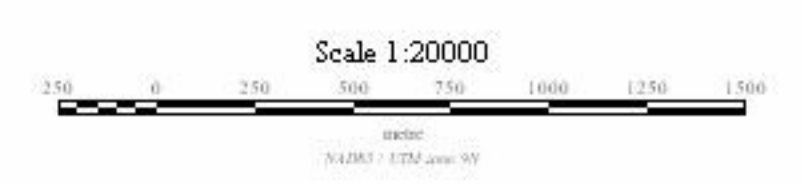
7200 Hz COPLANAR APPARENT RESISTIVITY

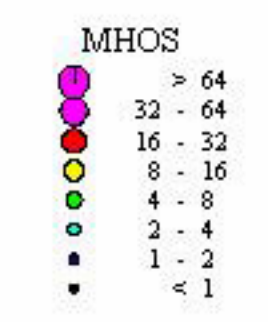

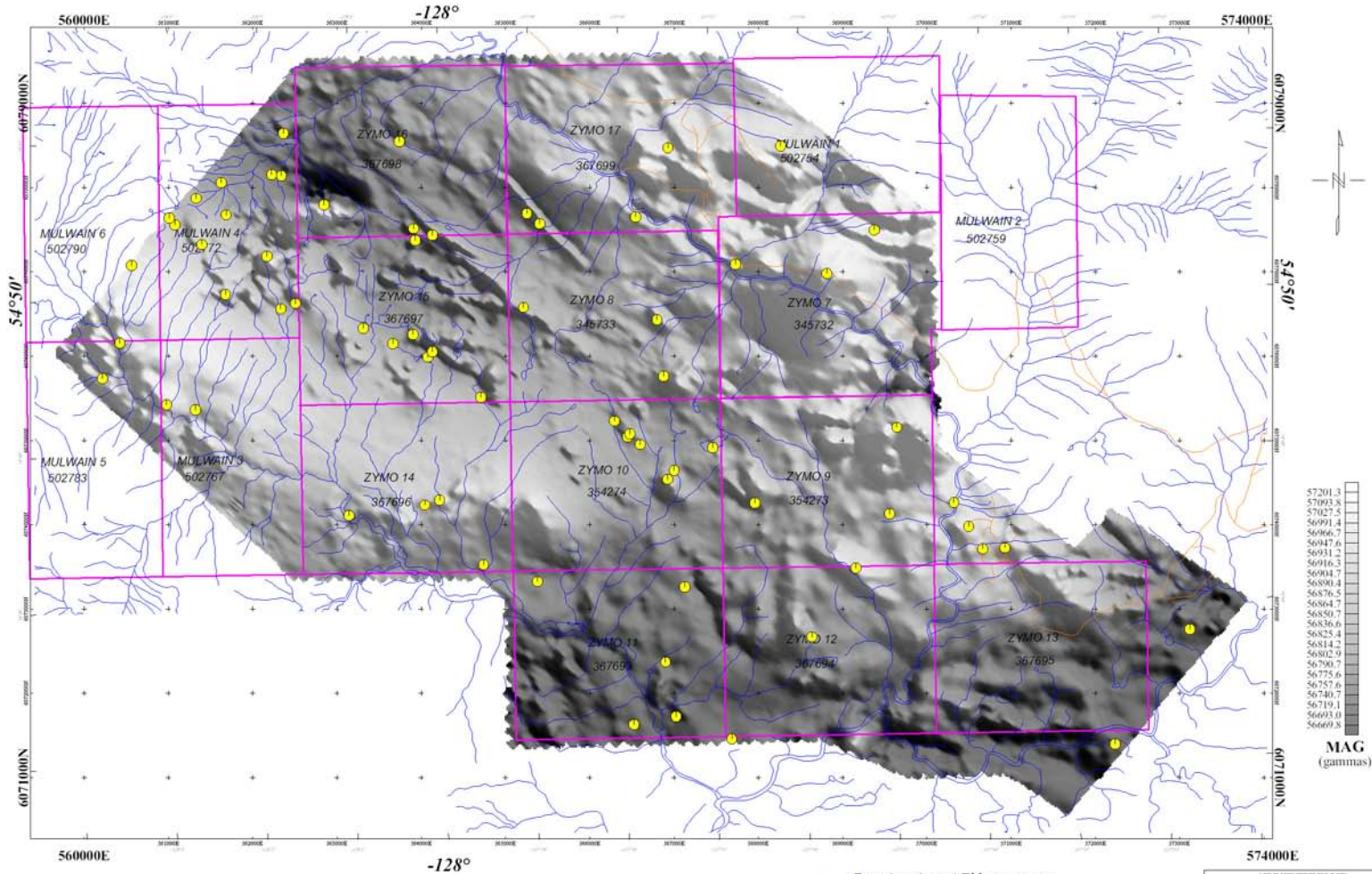
