#### **Introduction & Location**

The Fox2 property, tenure #617223, lies approximately 17 air kilometers due-east of the City of Hope. The tenure is an eight cell mineral claim situated on Montigny creek, a small tributary of Sowaqua Creek. Sowaqua Creek is a northwesterly flowing tributary of the Coquihalla River. The property lies within the Coquihalla Gold Belt, a northwest trending mineralization zone, underlain by the Hozameen Fault. The general area is well notarized for hosting gold-bearing mineralization, with the more prominent deposit being that of the Carolin Mine, located approximately 15 kilometers to the northnorth west.

#### Access

Leaving the City of Hope, travel north on Hwy 5 (Coquihalla Hwy) approximately 22kms, then exit the highway at the Sowaqua Creek turn off. Travel down the exit ramp and enter the large gravel parking area; on your left is the sign denoting the entrance to the Sowaqua Creek Forestry road. Travel up this rough (some heavy rain damage & washed out areas) two-lane gravel road 14kms to reach the western boundary of the claim.

### **Previous Work in the Area**

On investigation into the Sowaqua Creek Valley, I found two historical Minfile reports (092HSW148 & 092HSW080) and an Aris report 11449 that revealed some values of gold and platinum had been found. I did not find any reference to Montigny Creek.

### **General Area Geology**

In reference to the above noted work reports, the tenure's area generalized geology is described as being underlain by Permian to Jurassic Hozameen Complex rocks comprised mainly of inter-bedded chert, pelite and volcanic sandstones with distinct gray and black banding. The ultramafic rocks which occur along the Hozameen fault are part of the Coquihalla Serpentine Belt. Thirty-three samples containing silica with visible pyrhotite and pyrite were assayed. Assays yielded traces of gold, silver, copper and nickel (Assessment Report 11449).

#### **Summary**

We made 3 trips to the claim this season. A three man work party on March 29th & 30<sup>th</sup>, 2014 and a two man work party on October 13<sup>th</sup>, 2014. We prospected along the north bank of Montigny Creek, across the creek from the area prospected last season. We parked our vehicle at the terminus of a logging spur road that exits to the left from Sowaqua Creek FSR at 13.5kms from the Coquihalla Hwy. The creek is in a very deep ravine at this point and so we prospected along the upper bank and into the steep hill side.

From the vehiele, we hiked approximately .8-1.3 kilometers along the ridge of the creek gulley. We moved boulders and dug holes to obtain numerous grab samples. During the March trip, we sifted and classified approximately 1000 kilograms of the raw material on the site down to .45mm minus. We collected approximately 125 kilograms of concentrated material for further processing. We then filled in the holes and raked the surface.

During the October trip, we continued prospecting further upriver from where we finished in March. We returned with approximately 100 kilograms of concentrated material for further processing.

### Conclusions

Using manual crushing methods and hydro emulsion processes, we separated and inspected the material. The material from this area produced numerous small flakes of gold, approximately 6.0 grams total. It was decided that further exploration was required. The tenure was renewed for another term.
